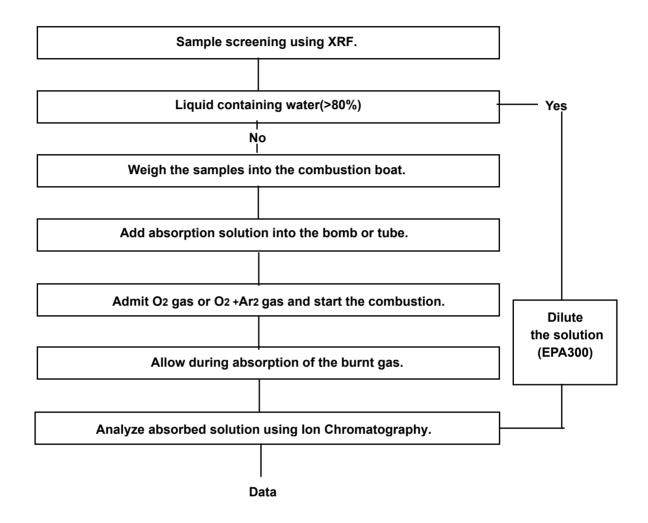

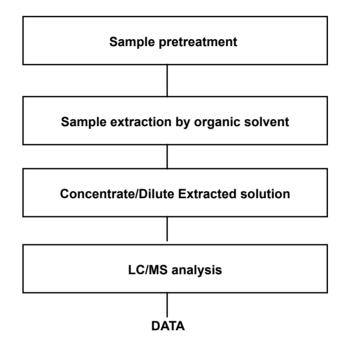

**Testing Flow Chart for HBCD** 



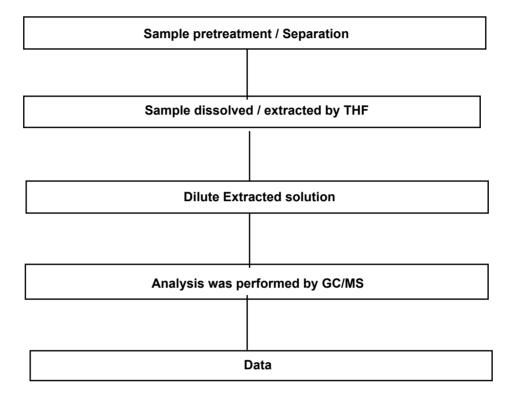
